<u>DISTRICT 3 SUMMARY</u>: 100% of Nine Counties reporting: 307 Members (+1 change); (64 Voice Net Sessions, 16 Digital Net Sessions (80 total Net Events & 376 Net man-hours); 20 Meetings-Drills-Training-Tests (390 man-hours); 5 Public Service Events (258 man-hrs) and 0 Emergency Operations (0 man-hrs); for 105 Total Events and 1024 Total man-hours.

<u>CHAMPAIGN COUNTY</u>: (23 members, 0 change): 5 weekly voice net sessions (50 Net manhours); 0 Public Service Event (0 man-hours); 0 Emergency Operations (0 man-hours) and 2 other ARES events (0 man-hours) for a total of 5 events and 50 man-hours.
